ADVERTISEMENT NOTICE

Applications are invited for filling up **18 (Eighteen) posts** of Clerk in this Sessions Division, purely on adhoc basis for a period of six months or till the regular appointments are made by the Hon'ble High Court of Punjab and Haryana, Chandigarh, whichever is earlier on consolidated pay of ₹25,500/- (minimum of pay scale of Clerks). The number of posts may increase or decrease due to creation or withdrawal of courts or otherwise.

QUALIFICATION

- 2(a) No candidate for direct recruitment shall be eligible to apply for the post of Clerk unless he holds a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized university and has passed matriculation examination with Hindi as one of the subject.
- (b) Candidates shall have to take a written examination in the following subjects:-

Sr. No.	Subject	Maximum Marks	Qualifying Marks
1	English Composition	50	33%
2	General Knowledge	50	33%

- (c) No candidate shall be considered for appointment unless he obtains 40% marks in aggregate in the written examination and has qualified the proficiency test in operation of computers (Word Processing and Spread Sheet) (Final merit list will be prepared on the basis of aggregate marks obtained in written examination only & marks of Computer Proficiency Test (CPT) will not be added while preparing final merit list).
- 3 Number of aforesaid posts can be increased or decreased due to administrative reasons.
- 4 **AGE LIMIT:** No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 01.01.2025. Upper age limit is relaxable as per instructions of Hon'ble High Court and as prescribed by Haryana Government from time to time.
- 5 **LAST DATE:** The last date for receipt of applications in the office of District and Sessions Judge, Narnaul, shall be **22.12.2025 by 05:00 PM.** No application received thereafter shall be entertained in any case. Delay on the part of postal authorities shall not be a ground for entertaining the applications received after due date.

- 6 **DATE AND PLACE OF TEST:** The applicants who fulfill the aforesaid qualification for the post of Clerks on adhoc basis will appear for written examination/computer proficiency test on the **date and venue to be intimated later on the official website of this office i.e. <https://narnaul.dcourts.gov.in/recruit>**. The applicants shall bring their original testimonials at the time of written examination. No separate call letters for the written examination / computer proficiency test shall be sent to the applicants.
- 7 The applications on plain paper with recent passport size photograph of candidate affixed thereon containing full particulars i.e. name, father's/husband's name, date of birth, sex, educational qualification, category, permanent address, correspondence address, contact / mobile number(s), e-mail id, experience, if any, alongwith attested copies of the relevant documents/certificates should reach in the office of District and Sessions Judge, Narnaul either by registered post/speed post or by hand well before the closing date i.e. **22.12.2025 by 05:00 PM.**
- 8 The incomplete applications and submitted without signature, photographs and attested copies of the relevant documents/certificates shall be straightway rejected without any information to the candidates.
- 9 No correspondence whatsoever shall be entertained in respect of incomplete applications or those which are received in this office after closing date.
- 10 The candidates qualifying the written test will be subjected to written/oral test for proving their proficiency test in operation of computers (word processing and spread sheets).
- 11 No TA/DA is admissible to any candidate appearing in the written/computer proficiency test for the post mentioned above.
